



# 2021 DOG LICENSE APPLICATION

City of Reedley Municipal Code, 5-3-15 states that every person owning, possessing, keeping, harboring or having custody of a dog over four (4) months old shall obtain a license for each dog. Such license shall be obtained, and the applicable license fee paid within thirty (30) days after the day on which a dog reaches four (4) months old, or within thirty (30) days of moving to the city. A license shall not be issued for any dog unless a valid certificate of rabies vaccination signed by a duly licensed veterinarian showing that the dog has been vaccinated within the prior twelve (12) month is presented and the applicable license fee paid.

1. Provide a **copy** of the **current vaccination certificate** valid for at least one year; if the dog is under quarantine, do not vaccinate until the dog is released from quarantine. **DO NOT SEND ORIGINALS, THEY WILL NOT BE RETURNED.**
2. Provide a **copy** of the **spay/neuter certificate**, where applicable. If you have lost this certificate, obtain a copy from your veterinarian, or send a statement signed and dated from your veterinarian that your dog has been spayed/neutered.
3. Provide the **license tag number**, if your dog has been previously licensed.

By signing below, I agree to inform the City of Reedley City Hall, 845 G. Street, Reedley, CA, 559-637-4200, of any ownership changes to the following dogs. I also understand that the license will be renewed January 1 of each year, and that I will be billed annually for the licensing fee.

# License Terms and Conditions

(City of Reedley Municipal Code 5.03.9, 15-16)

1. No person shall keep, harbor or maintain upon his or her premises within the city more than a total of five (5) dogs over the age of 4 months.
2. Exemptions include:
  - Service Dogs for The Disabled: Dogs being raised, trained and used to aid disabled persons shall be licensed without fee. Such dogs shall be either a guide dog, service dog, or signal dog as defined in California Civil Code section 54.1.
  - Government Dogs: Dogs owned and used by the city, county, or other public agencies, including dogs used by law enforcement agencies in the performance of law enforcement activity, shall be licensed without fee.
  - Temporary: Dogs brought into the city for the purpose of participating in any dog show or whose owners are nonresidents or temporarily within the city for a period not exceeding thirty (30) consecutive days need not be licensed. (Ord. 2009-04, 9-22-2009)
3. The license tag must, in all cases and at all times, be fastened to a suitable collar worn around the neck of the dog for which it was issued. Whenever a tag issued for the current year has been stolen or lost, the owner of the dog for which the tag was issued may request a replacement tag.
4. No refunds or credits shall be made on any license because of the death of any licensed animal or the owner leaving the city before the expiration of the license period. (Ord. 2009-04, 9-22-2009)

### Quarterly Fees

January – March: \$24.00/Unaltered; \$12.00/Spayed/Neutered

April – June : \$18.00/Unaltered; \$9.00/Spayed/Neutered

July – September: \$12.00/Unaltered; \$6.00/Spayed/Neutered

October – December: \$6.00/Unaltered; \$3.00/Spayed/Neutered
