

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF REEDLEY, ADDING A NEW CHAPTER 4 TO TITLE 2, RECODIFYING CHAPTERS 1 AND 3 OF TITLE 2, AND AMENDING VARIOUS PROVISIONS OF CHAPTERS 1, 2, 3, 5 AND 6 OF CHAPTER 2 OF THE REEDLEY MUNICIPAL CODE, CREATING A TRAFFIC SAFETY COMMISSION, REDUCING THE TERM LENGTHS AND NUMBERS OF COMMISSIONERS OF VARIOUS COMMISSIONS, AND MAKING RELATED CHANGES RELATING TO THE COMMISSIONS

SECTION 1: A new Chapter 4 of Title 2 of the Reedley Municipal Code is hereby enacted to read as follows:

"CHAPTER 4

"TRAFFIC SAFETY COMMISSION

"SECTION:

- "2-4-1: Commission Created; Purpose**
- "2-4-2: Membership**
- "2-4-3: Terms**
- "2-4-4: Vacancy**
- "2-4-5: Officers; Meetings**

"2-4-1: COMMISSION CREATED; PURPOSE: A Traffic Safety Commission in and for the City of Reedley is hereby created. It shall consist of five (5) members. The Commission shall be an advisory, investigative, and fact-finding body for the City Council on matters relating to traffic safety, including vehicular parking restrictions in the public right-of-way and the implementation of the school traffic safety program.

"2-4-2: MEMBERSHIP: Members of the Traffic Safety Commission shall consist of the Chief of Police, a School District Representative, and three (3) citizens who are residents of the City. The three (3) citizen members shall be appointed by the mayor subject to the approval of the City Council.

"2-4-3: TERMS: Citizen members of the Traffic Safety Commission shall be appointed for a term of three (3) years.

"2-4-4: VACANCY: Should a citizen member vacancy occur other than by expiration of term, it shall be filled by a Commissioner appointed for the remainder of the unexpired term. Each commissioner shall hold office until his or her successor is appointed and qualified.

"2-4-5: OFFICERS; MEETINGS: The Traffic Safety Commission Chair and Vice-Chair shall be resident-citizen members of the Commission appointed at-large. The Commission shall hold meetings as called for by the Chair or at the request of a quorum of the membership, and shall adopt rules for the conduct of business and shall keep accurate records of its minutes, resolutions, transactions, findings and determinations, which records shall be a public record maintained in the Clerk's Office."

SECTION 2: Reedley City Council Resolution 4176, regarding the Traffic Safety Committee, is hereby rescinded.

SECTION 3: Chapter 3 of Title 2 of the Reedley Municipal Code is hereby recodified as Chapter 1 of Title 2 of that Code, the designations of sections 2-3-1, 2-3-2, 2-3-3, 2-3-4, and 2-3-5 being hereby redesignated respectively as sections 2-1-1, 2-1-2, 2-1-3, 2-1-4, and 2-1-5; and former sections 2-3-2, 2-3-3, and 2-3-4 are hereby amended to read as sections 2-1-2, 2-1-3, and 2-1-4, respectively, as follows:

"2-1-2: REMOVAL OF APPOINTEE MEMBERS:

(A) Any appointee member of any commission may be removed by any of the following:

1. The appointing official, subject to approval of the legislative body.
2. A four-fifths (4/5) vote of the legislative body.
3. For absenteeism as provided in section 2-1-3."

"2-1-3: ABSENTEEISM OF APPOINTEE MEMBER: If any appointee commission member absents himself or herself from three (3) regular meetings during any calendar year, his or her position becomes vacant and shall be filled as any other vacancy. Exception to this rule may be made for long-term illness upon approval of the City Council."

"2-1-4: LIMITATION OF NUMBER TO TWO TERMS: Unless there are no new applicants, no person appointed to a commission of the City of Reedley shall serve more than two (2) consecutive terms on said commission, regardless of the length of the original term, except:

- (A) The above provision shall not apply on a four-fifths (4/5) vote of the City Council suspending said provision or when a member has been appointed to fill a vacancy with less than one-half (1/2) of the balance of the term remaining to be served; and
- (B) A member who has served two (2) consecutive terms shall be eligible to serve on a City Commission other than the one on which he or she served two consecutive terms, but in any event may serve on only one commission at a time."

SECTION 4: Chapter 1 of Title 2 of the Reedley Municipal Code is hereby recodified as Chapter 3 of Title 2 of that Code and the designations of sections 2-1-1, 2-1-2, 2-1-3, and 2-1-4 are hereby redesignated respectively as sections 2-3-1, 2-3-2, 2-3-3, and 2-3-4.

SECTION 5: (A) Sections 2-2-2 and 2-2-3 of the Reedley Municipal Code are hereby amended to read, respectively, as follows:

“2-2-2: **MEMBERSHIP:** The Commission shall consist of five (5) members. The said commissioners shall be appointed by the Mayor subject to approval of the City Council. All Commissioners shall be permanent residents of the City. Each Commissioner shall hold office until his successor is appointed and qualified.

“2-2-3: **TERMS:** Members of the Commission and their successors shall be appointed for terms of three (3) years each.”

(B) The present expiration dates of the terms of members of the Recreation and Park Commission who are serving on said Commission as of the effective date of this ordinance shall, notwithstanding the provisions of section 2-2-3 amended by this section 5, continue to be the expiration dates of said terms.

SECTION 6: Section 2-5-3 of Title 2 of the Reedley Municipal Code is hereby amended to read as follows:

“2-5-3: **TERMS:** Members of the Commission and their successors shall be appointed for terms of three (3) years each.”

SECTION 7: (A) Section 2-6-3 of Title 2 of the Reedley Municipal Code is hereby amended to read as follows:

“2-6-3: **TERMS:** Members of the Commission and their successors shall be appointed for terms of three (3) years each.”

(B) The present expiration dates of the terms of members of the Airport Commission who are serving on said Commission as of the effective date of this ordinance shall, notwithstanding the provisions of section 2-6-3 amended by this section 7, continue to be the expiration dates of said terms.

SECTION 8: (A) Subdivision (B) of section 10-14-6 of Title 10 of the Reedley Municipal Code is hereby amended to read as follows:

“(B) **Committee Members:** Said Committee shall be made up of three (3) members appointed by the City Council from the current list of owners of businesses within said area. Only those persons continuing to own businesses within the said area may retain their appointments on said Committee for the time as specified herein.

Each member or successor member shall be appointed or reappointed for a three (3) year term. The Committee shall appoint a chairman and such other officers from their number as they see fit to carry on the duties as set forth herein. The Director of Community Development of the City shall serve as a resource person and staff liaison to the Committee in carrying out its duties."

(B) The present expiration dates of the terms of members of the Reedley Downtown Parking and Business Improvement Area Committee who are serving on said Committee as of the effective date of this ordinance shall, notwithstanding the provisions of section 10-14-6 amended by this section 8, continue to be the expiration dates of said terms.

This ordinance shall take effect thirty (30) days after its adoption and shall be published once in the Reedley Exponent within fifteen (15) days after its adoption.


